Although less likely than Cr(VI) compounds, the NTP considers all chromium to be potentially carcinogenic. Inorganic bromides may produce depression, emaciation and in severe cases, psychosis and mental deterioration. Bromoderma, a bromide rash, often occurs when bromide inhalation or administration is prolonged. This rash is usually found on the face and resembles acne and furunculosis.
