Germanium compounds generally have a low order of toxicity. High doses have resulted in kidney and bladder injury. The anion and compound reactivity may contribute the greater part of the toxicity. Prolonged exposure to iodides may cause skin rash, running nose, headache and irritation of the

mucous membranes. In severe cases the skin may show pimples, boils, redness, black and blue spots, hives and blisters. Iodides are readily diffused across the placenta.
