Barium compounds may cause severe gastroenteritis, including abdominal pain, vomiting and diarrhea, tremors, faintness, paralysis of the arms and legs, and slow or irregular heartbeat. Severe cases may produce collapse and death due to respiratory failure. Soluble barium compounds are more likely to cause these effects than insoluble compounds. Inhalation of fumes may cause sore throat, coughing, labored breathing, and irritation of the respiratory tract as well as the above symptoms. Subacute to chronic toxicity: No effects known.

Subacute to chronic toxicity:

Boron affects the central nervous system. Boron poisoning causes depression of the circulation, persistant vomiting and diarrhea, followed by profound shock and coma. The temperature may become subnormal and a scarletina form rash may cover the entire body.

To the best of our knowledge the acute and chronic toxicity of this substance is not fully known.
