Subacute to chronic toxicity:
Carbonyl compounds are toxic due to decomposition yielding carbon monoxide. Symptoms include asphyxia, headache, mental confusion, dizziness, impairment of vision and hearing, and fainting. High exposures can result in unconsciousness and death due to the inability of hemoglobin to carry oxygen to the tissues.
Exposure to iridium compounds may cause irritation to the eyes or respiratory tract. Toxicity of iridium is not known. It is predicted to have toxicity similar to osmium and platinum, two members of the same group.
Subacute to chronic toxicity: No effects known.
Subacute to chronic toxicity:
2,4-Pentanedione (acetylacetone), if present or released, is harmful if swallowed, and may irritate the eyes. 2,4-Pentanedione has caused reproductive effects in laboratory animals and is also flammable.
