pressure. Central nervous system effects may include slurred speech, blurred vision, dizziness, sensory loss, convulsions and stupor. Chronic intake may cause

neuromuscular effects such as tremor, ataxia, weakness, clonus and hyperactive reflexes. Lithium can cause kidney damage, gastrointestinal disturbances, fatigue,

dehydration, weight loss, dermatological effects and thyroid damage. Lithium ion has shown teratogenic effects in rats and mice.

Gold compounds may cause irritation to the eyes and respiratory tract. Aplastic anemia may result from damage to the blood forming organs. Gold has caused

tumors and reproductive effects in laboratory animals via implant, intraperitoneal and subcutaneous routes.
