Ingestion of mineral spirits may cause a burning sensation in the mouth, esophagus and stomach.

Vomiting, blurred vision, diarrhea and CNS effects may occur.

Swallowing may cause aspiration into the lungs. Inhalation may cause intoxication, peripheral nerve disorders and CNS depression. They are suspected carcinogens of the skin, scrotum, larynx, lung and alimentary tracts.
