SECTION 4. FIRST AID MEASURES

Inhalation: May cause coughing, difficult breathing and nausea. Call a poison center or doctor if you feel unwell.

Ingestion: Harmful if swallowed. Effects of exposure (ingestion) to substance may be delayed. Call a

physician or

Poison Control Center immediately. Do not use mouth-to-mouth method if victim ingested the substance;

give artificial respiration with the aid of a pocket mask equipped with a one-way valve or other proper respiratory medical device. Loosen tight clothing such as a collar, tie, belt or waistband. If a person vomits

place them in the recovery position so that vomit will not reenter the mouth and throat. Rinse mouth.

Keep

victim warm and quiet. Treat symptomatically and supportively. Ensure that medical personnel are aware

SECTION 6. ACCIDENTAL RELEASE MEASURES

Warn

and/or a leak, always shut off any sources of ignition, ventilate the area, and exercise caution. Do not touch damaged containers or spilled material unless wearing appropriate protective clothing. Warn personnel to move away. Prevent entry into sewers, basements or confined areas; dike if needed.

Methods and materials for containment and cleaning up:

ELIMINATE all ignition sources (no smoking, flares, sparks, or flames in immediate area). Stop leak if without risk. Ventilate the area. Absorb with an inert material and put the spilled material in an appropriate waste disposal container. Use clean non-sparking tools to collect absorbed material.

Environmental precautions:

Keep away from living quarters. Prevent further leakage or spillage if safe to do so. Water runoff can cause environmental damage. Prevent entry into sewers, basements or confined areas; dike if needed.
