Fluorides may cause salivation, nausea, vomiting, diarrhea and abdominal pain, followed by weakness, tremors, shallow respiration, convulsions and coma. Maycause brain and kidney damage. Chronic fluoride poisoning can cause severe bone changes, loss of weight, anorexia, anemia and dental defects.

Inhalation of magnesium compounds may cause metal fume fever.

Metallic magnesium which perforates the skin may cause local lesions. Some magnesium salts have produced muscle weakness, cardiac arrhythmias, respiratory effects and changes in blood chemistry following ingestion.
